Blockchain and Crypto asset industry has grown exponentially in Indonesia over 6 years.

The total transaction of crypto assets has decreased in significantly to Rp. 279,8 Trillion in January-October 2022 compared to Rp. 717,99 Trillion in the same period previous year.

The total transaction has decreased 61,03%

From Jan - October 2022, total transaction have reached Rp. 279,8 Trillion

Total digital economic growth in Indonesia

In 2022, the value of digital economic growth has reached US\$ 70 million in line with greater public acceptance and growing public preference towards online retail, coupled with the support of digital payment system expansion and digital banking acceleration. And expected to raise to US\$ 130 million by 2030.

The Central Bank begins exploring the design and issuance of CBDC

The crypto asset is also the reason Bank Indonesia (BI), as central bank, exploring the high-level-design and issuance of the Central Bank Digital Currency (CBDC) which called "Proyek Garuda". With Indonesia's G20 Presidency, nation's objectives have lead to realization in the need of support and input from the industry as way to develop the CBDC initiative and design into ideal point.







Tax on Crypto Assets

Minister of Finance Regulation No. 68/PMK.03/2022 concerning Value Added Tax (PPN) and Income Tax (PPh) on Crypto Asset Trading Transactions.

The total tax revenue on crypto asset until October 2022 has reached Rp. 191,11 million.

CoFTRA release the list of Crypto Assets that can be traded in Indonesia

The recent CoFTRA Regulation No. 11 of 2022 about Establishment of a List of Crypto Assets Traded in the Crypto Asset Physical Market has changed the previous 299 list into 383 with multiple over-turn.







CoFTRA issued a new regulation (Perba) on Crypto Asset Trading

CoFTRA/Bappebti recently published new regulation which is <u>Regulation Number 13 of 2022</u> concerning <u>Guidelines for the Physical Crypto Asset Market Trading on the Futures Exchange</u> that amended the previous CoFTRA Regulation No. 8 of 2021, specifically in registration requirements for Crypto Exchanges, licensing requirements for Crypto Futures Exchange, transparency in reserves and fund management, auditing obligations, and prohibition of introducing broker business in crypto asset transactions, and more.

Finalization on new bill with Crypto Asset under OJK (Financial Services

Authority/FCA)

House of Representatives passed the new bills on Strengthening and Development of the Financial Sectors (PPSK) that was initiated back in 2020 and will include crypto assets as part of Financial Sector Technological Innovation (ITSK) with regulatory and supervisory under OJK.
